## About our Service

We've put together answers to the most commonly asked questions about our service.

**Is it free?** We work under a funded agreement with Somerset County Council to provide support to schools, early years providers and parents. The service is free at the point of delivery for early years settings, but is chargeable at £38 per hour for schools.

**What can you help with?** Our agreement is to provide help for speakers of Polish.

- In-class support
- Translating materials for parents
- Interpreting at parent-teacher meetings
- Helping parents to overcome language and cultural barriers to participation in their child's education

**How often can your support workers come to class?** Most schools and EYS require one morning or afternoon each week.

**Can you provide online help?**

- We can always help with online (and telephone) interpreting. It can be a good way to help with parent-teacher meetings too.
- We have capacity at some times during the year to work 1:1 with children online.

## EUSS Status Update

June 30 was the deadline for EEA/Swiss citizens to have applied to the EU Settlement Scheme for status to preserve their rights to live and work in the UK.

You may find children in your school or early years setting that have not had an application made for them.

Not to worry! In most cases, they have an indefinite right to have a late application made for them (as long as they were under 18 before the deadline date).

Parents who have not yet applied may be able to make a **late application** if they can show good cause, and we urge anyone who has not yet done so to do this now, if they are eligible.

Diversity Voice is registered with the Office of the Immigration Services Commissioner to provide assistance to those applying to the EUSS.
